CONDITIONS:

1. Operation of this equipment shall be conducted in compliance with data and specifications submitted with the application under which this permit is issued unless otherwise noted below. [Rule 204]
2. This equipment shall only be operated/maintained in strict accord with manufacturer's or suppliers recommendations and/or sound engineering principles.[Rule 204]
3. All coatings, diluents, thinners, solvents, application methods, and record keeping, shall comply with District Rules 107, 442, and 1320 in their entirety. These rules pertain to Record Keeping, and Products Coating Operations, Solvent Cleaning Operations, and New Source Review For Toxic Air Contaminants respectively. [Rule 204]
4. The total amount of volatile organic compounds (VOCs) emitted from this facility shall not exceed 4150 pounds per month, based on a 12-month rolling average, and shall not exceed 24.9 TPY, defined as 12 consecutive months. [Rule 204]
5. This facility shall not emit more than the following tonnages per year on a 12-month rolling total:
 - A. PM10: 14.9 tpy
 - B. NOx: 24.9 tpy

E. TACs/HAPs shall not exceed 9.9 tons per year for any single HAP and 24.9 tons per year for any combination of HAPs. Total emissions of Federal Hazardous Air Pollutants or HAP (as listed in Section 112(b) of the Federal Clean Air Act, see <http://www.epa.gov/ttn/atw/orig189.html>) [Rule 1303; Rule 204]

6. The following records shall be maintained by the owner/operator of this facility:

A. MSDS documents for all coatings, solvents, cleaning agents, etc, including the density, and VOC amount.

B. A list of all California Toxic Air Contaminants (TACs) and Federal Hazardous Air Pollutants (HAPs)

C. Hours operated per day

D. Quantity of each material used per month

E. Monthly emissions of VOCs, TACs and HAPs

F. Twelve month rolling average of emissions.

This information shall be maintained on-site for a minimum of two years and off-site for a total of five (5) years and be provided to District, State and Federal personnel upon request. (Note: The records provides a basis for the Emission Inventory Reports.) [Rule 204]

7. The total amount of volatile organic compounds (VOCs) emitted from this facility shall not exceed 4150 pounds per month, based on a 30 day rolling average, and shall not exceed 24.9 TPY, defined as 12 consecutive months. [Rule 204]

8. Pursuant to 40 CFR 63 subpart HHHHHH, this facility shall not spray apply coatings to metal and plastic surfaces that contain compounds of chromium (Cr), lead (Pb), manganese (Mn), nickel (Ni), or cadmium (Cd) after January 9, 2011. (Contact the MDAQMD for additional permit conditions if this facility will use MeCl) [Rule 204]

9. Pursuant to 40 CFR 63 subpart HHHHHH, this facility shall not conduct any paint stripping operations on any substrate that use methylene chloride (MeCl)-containing paint stripping formulations. (Contact the MDAQMD/AVAQMD for conditions if this facility will use MeCl for additional permit requirements.) [Rule 204]
