PROCESS LINE #2 consisting of:Weighing, conveying, conditioning, extruding, drying/cooling, sizing, coating, and final cooling equipment. Equipment that is common to all process lines is included in Process Line #1 (B008780). For rating purposes, 1 brake-horsepower is equal to 2544 Btu/hour. Note: PM-10 emissions is limited to less than 93,437 pounds per year (46.72 TPY). It is noted that PM-10 emissions have been fully offset to this amount through a series of previous NSR activities pursuant to District Regulation XIII. Facility elevation is 2930 feet above sea level.
