- 1. Operation of the equipment described above shall be conducted as described in the data and specifications submitted with the application under which this permit is issued unless specifically exempted hereunder. [Rule 204]
- 2. This rock crushing plant shall only be operated/maintained in strict accord with manufacturer's supplier's recommendations and/or sound engineering principles. [Rule 204]
- 3.Roadways, work areas, stockpiles, and materials being processed shall be kept wetted to control fugitive dust. Equipment to properly wet the material being processed shall be maintained in operable condition on-site and used as necessary to assure compliance. [Rule 401, 403, 1303]
- 4. Water sprays shall be used at conveyor points of charge and discharge, crushers, feeders, and screens, to control fugitive emissions. [Rule 401, 403, 1303]
- 5. Daily production logs shall be maintained on-site for at least two (2) years and made available to District personnel upon request. This log shall contain, as a minimum, the tons of product produced per day (summarized monthly), and the total number of hours operated. [Rule 1303]
- 6.The owner/operator shall comply with all applicable Rules and Regulations of the District. Applicable rules include, but are not necessarily limited to Rules 401, 402, and 403.
- 7.This equipment shall not be operated unless powered by the 300 bhp internal combustion engine operating under valid district permit B008949. [Rule 204]
- 8.Annual (rolling 12 month sum) throughput shall not exceed 75,600 tons (based on 150 tph and 504 hour/year). [Rule 1303]
