OneOnan/Cummings, Diesel fired internal combustion engine Model No.DGBB-4478022 and Serial No.C000078159, producing63 bhp with4 cylinders at 1800 rpm while consuming a maximum of 3.0 gal/hr. This equipment powers a Pump Model No. and Serial No., rated at.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.
- 2. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15 ppm) on a weight per weight basis per CARB Diesel or equivalent requirements. (17 CCR \S93115(e)(1)(A))
- 3.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. (17 CCR \S93115(e)(4)(G)1.)
- 4.The o/o shall maintain a operations log for this unit current and on-site (or at a central location) for a minimum of three (3) years, with records kept on-site for two (2) years, and be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below: a. Date of each use and duration of each use (in hours); b. Calendar year operation in terms of fuel consumption (in gallons) and total hours; and, c. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log).

- 10. The owner/operate must submit the required emissions data to District prior to appropriate compliance date(s) in either Conditions 7 or 8 for the engine. (17 CCR \S93115(e)(4)(D))
- 11. This diesel fired ICE is subject to the requirements of the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines (17 CCR 93115). In the event of conflict between these Conditions and the ATCM, the more stringent requirements shall govern.
- 12. This ICE is currently in Violation of the Diesel ATCM emission reduction timeline; the owner/operator shall take immediate steps to replace this unit with one that is at least Tier III compliant. A District approved Authority To Construct Permit is required prior to changing equipment.
