BOILER, NATURAL GAS consisting of: Rite Engineering & Manufacturing Corp model # W275WG, Rated at 2.56 MMBtu/hr, with a maximum heat input of 2.8 MMBtu/hr, equipped with (2) American Combustion Tech low-NOx burners, model 03G-SLE fired only with natural gas

#### **CONDITIONS:**

1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
3. The operator shall maintain a log for this equipment, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
  - a. Cumulative annual fuel use in cubic feet or operation in hours; and,
  - b. Annual tune-up verification.
4. Prior to the expiration date each year the o/o shall have this equipment tuned, as specified by Rule 1157.
5. This boiler shall only be fueled with utility grade natural gas.
