Description:

MP50/MP85 PROCESS LINE consisting of:Two 57 liter stainless steel reaction chambers used to produce MP50/MP85 silica products. This system also includes two product rinse tanks, rinse tank drains (to the waste water treatment system), various ancillary equipment, pumps, valves, etc., and a vent fan which exhausts directly to atmosphere.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rules 203 and 1302]
- 2. This process line shall emit no more than 20 pounds of Hazardous Air Pollutants (HAPs) to the atmosphere per day, verified by usage records and a mass balance calculation. Furthermore, this process line shall not produce more than a combined total of twenty five (25) batches of MP50 and/or MP85 per calendar day. This combined total does not include any MP50 produced from the equipment described in District Permit B012332.

- 3.Emissions from this facility shall not exceed the following emission limits, based on a rolling twelve (12) month summary without first obtaining authorization from the District:
- a. VOC 40,000 pounds per year (20 tons per year)
- b. All HAPs combined 40,000 pounds per year (20 tons per year)

- c. Amount of daily HAP containing compounds used (by type/chemical name, HAP content, and amount);
- d. Monthly HAP emissions (by type/chemical name, HAP content, and amount); and,
- e. Cumulative rolling consecutive twelve month (Rolling Annual) summary HAP emissions (by type/chemical name, HAP content, and amount).
