- 2. This microturbine shall not be operated unless all emission control systems are properly functioning. Furthermore, no changes shall be made to any emission control system unless done so by a factory certified technician.

 [MDAQMD Rule 1302]
- 3. This equipment shall only be fired on diesel fuel that meets the following requirements:
- a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,
- b. A cetane index or aromatic content, as follows:
- 1. A minimum cetane index of 40; or,
- 2. A maximum aromatic content of 35 volume percent.

[MDAQMD Rules 204 and 431]

Note: Use of CARB certified ULSD fuel satisfies the above requirements. Use of Kerosene, JP-4, JP-5, and JP-8 are not authorized for use in this microturbine.

- 4. The owner/operator shall maintain an operations log for this microturbine current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the following information:
- a. Date of each maintenance action or repair;
- b. Description of each maintenance action or repair;
- c. Fuel sulfur concentration as required by condition #3 (the owner/operator may use the supplier's certification of sulfur content if it is maintained as part of this log); and,
- d. Results of any source testing conducted on the engine. IMDAQMD Rule 13021
- 5.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
