3.Dust and ash from this equipment shall be collected in such a manner as to ensure no visible emissions exceeding Ringelmann 1 (20 % opacity) are observed. Furthermore, the collected ash shall be stored and transferred in closed containers which preclude any visible emissions.

[District Rules 401 and 1302]

- 4.Operation of this equipment shall not cause or allow the discharge from any source whatsoever such quantities of air contaminants or other material which cause injury, detriment, nuisance or annoyance to any considerable number of persons or to the public, or which endanger the comfort, repose, health or safety of any such persons or the public, or which cause, or have a natural tendency to cause, injury or damage to business or property.

- 5. Operation of this equipment shall not cause or allow the emissions of fugitive dust from any transport, handling, construction or storage activity so that the presence of such dust remains visible in the atmosphere beyond the property line of the emission source. Furthermore, the facility shall take every reasonable precaution to minimize fugitive dust emissions from wrecking, excavation, grading, clearing of land and solid waste disposal operations.

- 6.The owner/operator shall maintain an operations log for this system current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Dates of transfers and quantities, in pounds, of ash transferred offsite; and
- b. Records of all repairs, maintenance actions, and inspections.
