#### Description:

FIRE FIGHTING TRAINING - BURN CAR consisting of: A mobile burn car to be used as a firefighting training simulation. This device is equipped with two (2) 250 gallon propane tanks, associated piping to distribute the fuel, and will be ignited to serve in firefighting training.

#### CONDITIONS:

1. This equipment (burn car operations) shall not be conducted within 1,000 feet of school boundaries.

2. Only propane can be used as fuel in the Burn Car. The maximum amount of propane that can be burned at any one time is 100 gallons, not to exceed 1,200 gallons per year.

3. The owner/operator must include the following information in an operations log. These records can be in either electronic or hardcopy format and shall be maintained on-site for at least two (2) years and made available to the District upon request.

- a. Date, time, and duration of each training burn,
- b. Quantity of propane burned in each training burn, and
- c. Person authorizing each training burn.
