Description:

CURING OVEN #1 consisting of: a natural gas fired paint curing oven manufactured by JPW , Model HD496, Serial No.002675, with 400,000 BTU modulating gas burner, External dimensions 6' 8" W X 10' H X 5' 6" L (Internal capacity of 96 cubic feet) with a maximum operating temperature of 500 degrees Fahrenheit, and operating temperature of 400 degrees Fahrenheit, and one 1.5 hp. exhaust motor at 700 cfm, with 6" diameter outlet. Stack Height 19' from ground level. Elevation: 2,616'.

CONDITIONS:

1. This equipment shall only be operated and maintained in strict accord with manufacturer's/supplier's recommendations. Operation of this equipment shall be conducted in compliance with data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
