CONDITIONS:

- 1.The owner/operator, o/o, shall operate all the equipment delineated above in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles, which produce the minimum of emissions.

 [District Rule 204]
- 2. This equipment shall not be operated unless Asphalt Oil Truck Unloading operations and process heater are vented through a properly operating integral Blue Smoke Condenser.

 [District Rule 401, 402, 1320]
- 3. This facility is limited to processing no more than 100,000 tons of recycled crumb rubber material in any consecutive 12 calendar month period.

[District Rule 1303, 1320]

- 4.A daily production and operation log shall be maintained current and on-site for two (2) years, and shall be provided to District personnel upon request. This log shall contain, at a minimum:
- a. Daily tonnage of crumb rubber processed;
- b. Monthly tonnage of crumb rubber processed; and
- c. Yearly (Calendar Year) tonnage of of crumb rubber processed.

5. This equipment and associated operations shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringlemann 1).

[District Rule 401, 402]

- 6.Materials processed by equipment delineated above shall contain sufficient natural and/or added moisture to ensure compliance with District rules 401, 402 and 403. Sufficient water and equipment in operable condition shall be maintained on-site and used as necessary to ensure compliance with these rules. This condition also applies to all haul roads and paved roads in and throughout the facility. [District Rule 204 and Regulation IV]
- 7. The owner/operator shall notify the District at least ten (10) days prior to operation of this equipment. Notification must be sent electronically to engineering@mdaqmd.ca.gov. The notification must include:
- a. The permit number.
- b. The location/address where the equipment will be operated.
- c. The estimated duration of the operation (including start up and stop dates).
- d. The contact information of the owner/operator of the equipment.

- 8. This equipment shall not operate concurrent with the asphalt and crumb rubber blending system under valid District permit B009515. [District Rule 1303]
- 9.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
