#### **Description:**

BOILERS consisting of: Two (2) identical RBI natural gas fired boilers Model DW1950 Serial Numbers 100851480 and 071674498 each rated 1.95 MMBtu/hour heat input equipped with low NOx burners and venting through separate vent stacks each 30 feet high and 18 inches in diameter.

#### **CONDITIONS:**

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

2. This equipment is limited to using only PUC-Regulated pipeline quality natural gas for fuel.

3. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:

a. Total fuel consumed on an annual basis

4. In order to remain below the 80% significance threshold for USEPA Major Source designation ("SM-80"), emissions from the entire facility shall not exceed the following limits:

- a. Oxides of Nitrogen (NO<sub>x</sub>): 20 tons per consecutive twelve month period, measured as NO<sub>2</sub>;
- b. Oxides of Sulfur (SO<sub>x</sub>): 20 tons per consecutive twelve month period;
- c. Volatile Organic Compounds (VOC): 20 tons per consecutive twelve month period;
- d. Carbon Monoxide (CO): 80 tons per consecutive twelve month period;
- e. Hydrogen Sulfide (H<sub>2</sub>S): 8 tons per consecutive twelve month period;
- f. Lead (Pb): 0.48 tons per consecutive twelve month period;
- g. Particulate Matter 10 microns and less (PM<sub>10</sub>): 12 tons per consecutive twelve month period;
- h. Any single Hazardous Air Pollutant (HAP): 8 tons per consecutive twelve month period; and
- i. All HAPs combined: 20 tons per consecutive twelve month period.

Compliance shall be demonstrated to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEI) or other equivalent and District approved method.

5. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
