- 1. This certified portable compression-ignited internal combustion engine and its associated emission control systems shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302; 40 CFR 60.4211(a)]
- 2. This engine shall not be operated unless all manufacturer-installed emission control systems are properly functioning. Furthermore, no changes shall be made to any of the emissions control systems unless done so by a factory certified technician. [District Rule 1302]
- 3. This equipment shall only be fired on diesel fuel that meets the following requirements, or an alternative fuel approved by the ATCM for Stationary CI Engines:
- a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,
- b. A cetane index or aromatic content, as follows:
- 1. A minimum cetane index of 40: or.
- 2. A maximum aromatic content of 35 volume percent.

[17 CCR 93115.5(a); 40 CFR 80.510(b)]

Note: Use of CARB certified ULSD fuel satisfies the above requirements.

- 4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [Title 17 CCR 93115.10(d)]
- 5. The owner/operator shall maintain an operations and inspection log for this unit, current and on-site (or at a central location), for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date of each use:
- b. Location of each use (decimal degrees, xx.xxxxx, -yyy.yyyy);
- c. Daily, Monthly, and 12 month rolling consecutive total hours of operation, as indicated by the hour meter readings;
- d. Records of all inspection, maintenance and/or repair actions performed on the engine, including date and description;
- e. Fuel sulfur concentration as required by condition #3 (you may use the supplier's certification of sulfur content if it is maintained as part of this log).

- 6. The emissions from this facility shall be less than the following limits:
- a. 8 tons per year of any single HAP or 20 tons per year of any combination of HAPs on a 12 month calendar year basis.
- b. 12 tons of PM10 per year calculated on a rolling twelve month summary basis.
- c. 20 tons of NOx per year calculated on a rolling twelve month summary basis.
- d. 20 tons of VOC per year calculated on a rolling twelve month summary basis.
- e. 80 tons of CO per year calculated on a rolling twelve month summary basis.
- f. 20 tons of SOx per year calculated on a rolling twelve month summary basis.

Compliance with this limit shall be verified with an emissions inventory as requested by the District. [District Rule 1303]

7. This engine is subject to the requirements of Title 17 CCR 93115, the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines and 40 CFR 60, Subpart IIII - Standards of Performance for Stationary Compression Ignition Internal Combustion Engines (NSPS). In the event of a conflict between these conditions and the ATCM or NSPS, the more stringent requirements shall govern.

8.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
