Description:

RAIL CAR CLINKER LOADOUT SYSTEM (PORTABLE) consisting of: Portable clinker rail car loadout system, consisting of: (1) Receiving Hopper and (1) Radial Stacker, manufactured by MGL, model SITE BOSS, serial no. SB848T120, with a maximum throughput rating of 500 tons/hr and (1) Funnel Hopper. Powered by one (1) DOORS registered Tier 4 Final 74 hp engine.

CONDITIONS:

1. The owner/operator (o/o) shall maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.

2. This equipment must be powered by either line power, a DOORS registered engine, a PERP registered engine, or by a District-permitted generator.
[District Rules 1302 and 1320]

3. A facility log shall be maintained on-site for at least five (5) years and made available to District personnel upon request. This log shall contain, as a minimum:

- a. Monthly (or as otherwise allowed by 40 CFR 63.1350) one-minute observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Monthly and consecutive 12 month summations of total product processed for the equipment permitted under MDAQMD permit no.

4. This equipment shall be operated in compliance with 40 CFR 63 Subpart LLL - National Emission Standards for Hazardous Air Pollutants from the Portland Cement Manufacturing Industry.
[District Rule 204; 40 CFR 63 Subpart LLL]

5. This equipment shall not discharge into the atmosphere an exhaust stream that exhibits greater than ten percent opacity.
[District Rule 204; 40 CFR 63.1343(b), 1345]

6. Emissions from this equipment have been offset by Simultaneous Emission Reductions (SERs) from the road paving project covering 14,900 square feet at the Packhouse Road roadway. Road start point is defined as: from lat/long of 34.60999/-117.34082, terminating at a lat/long of 34.60415/-117.33862. This road shall be maintained in good order, free from pot holes and excessive dirt as to minimize fugitive particulate emissions.

7. Annual throughput must not exceed 60,000 tons in any consecutive 12 month period. This limitation is specific to the material processed by the equipment permitted under this permit (MDAQMD Permit no. B015237). Prior to exceeding this throughput limitation, the owner/operator must submit an application to modify this permit to evaluate emissions offsets as required by District Rule 1303(B). The current throughput limitation may not be exceeded without a District-approved modified permit.

8. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
