- 3.An operations log shall be maintained on-site, or at a central location, for at least two (2) years and be made available to District personnel upon request. This log shall contain, as a minimum, the following:
- a. Daily and monthly records of the quantity of wastewater processed at this source;
- b. Repairs made to listed equipment (Note: This does NOT include routine maintenance actions); and,
- c. The total facility-wide Volatile Organic Compound (VOC) emissions, in pounds or tons, for the most recent calendar year. [District Rule 1302]
- 4. The facility shall not discharge from any source whatsoever such quantities of air contaminants or other material which cause injury, detriment, nuisance or annoyance to any considerable number of persons or to the public, or which endanger the comfort, repose, health or safety of any such persons or the public.

- 5. This equipment shall be operated and maintained in strict accordance with applicable federal, state, regional, and local waste discharge permits.

- 6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
