PLASMA CUTTER, DRAGON consisting of:Bend Tech, Model Dragon A400 tube and pipe plasma cutter, Serial Number TBD equipped with Bend Tech Dragon Material Coolant (water tray) System rated at 15,600 watts.

#### CONDITIONS:

1. This equipment shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]

2. The owner/operator shall not use the plasma cutter unless it is performed with properly maintained and functioning Dragon Material Coolant System in operation at all times when plasma cutting is being performed. [District Rule 1320]

3. Visible emissions from this facility shall not exceed an opacity equal to, or greater than, twenty percent (20%) for a period aggregating more than three (3) minutes in any one (1) hour, excluding uncombined water vapor. [District Rule 401]

4. Cutting of stainless steel is prohibited. [District Rule 1320]

5. The owner/operator shall limit plasma cutting of carbon steel alloys to 800 hours of operation in any consecutive twelve month period.

a. Total cutting time (minutes or decimal hours) or linear inches cut, alloy cut, and thickness of material cut each time the plasma cutter is used:

b. Monthly and consecutive twelve month total hours of operation; and,

c. Documentation of allov composition for all metal processed by this equipment.
