This program shall include, but not be limited to, regular opacity readings, pressure differential measurements, and maintenance inspections. Logging of these data shall be required with the log kept on-site for a minimum of two (2) years. This log shall be provided to District personnel on request.
- 3.The o/o shall conduct compliance tests relative to District Rules 404 and 405. Testing shall be every three (3) years starting in 1994 and the test results submitted to the District not later than six (6) weeks prior to the expiration date of this permit in those years
