- 4. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request. This equipment shall be operated concurrently with the Potash Truck Loadout Hopper & Conveyor covered by District Permit B003790.
- 5. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations to ensure compliance with District Rules. This program shall include, but not be limited to, regular opacity readings, pressure differential measurements, and maintenance inspections. Logging of this data shall be required with the log kept on-site for a minimum of two (2) years. This log shall be provided to District personnel on request.
- 6. The o/o shall conduct compliance tests relative to District Rules 404 and 405. Testing shall be every five (5) years from the initial compliance test. The District shall be notified at least ten (10) working days prior to the test date. The test results submitted to the District not later than forty-five (45) days following the tests in those years applicable.
