- 1.An annual compliance/certification test (source test) of this unit for particulate and PM10 is not required. However the o/o shall conduct such testing upon District request and shall be in accordance with the District "Compliance Test Procedural Manual".
- 2. Operation of this equipment shall be in strict compliance with the data and specifications submitted with the application for which this permit has been issued.
- 3. This unit shall be operated and maintained in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
- 4.An operating air lock device shall be fitted on each material discharge port.
- 5. This fabric dust collector shall be equipped with functioning pressure gauge to monitor the pressure drop across the unit.
- 6.The operating pressure drop across this fabric dust collector shall be kept between 1.5 and 4.0 in W.C.
- 7.Pressure drop readings shall be taken weekly and recorded in the maintenance/ operator's log. This log shall be maintained on-site for five (5) years and be made available to the District upon request.
- 8. The o/o shall maintain on-site, as a minimum, an inventory of replacement bags that assures compliance with applicable Rules of District Regulation IV.
