3. The o/o shall log all the items in 2 above, keep the log on-site for a minimum of 2 years and present it to District personnel on request.
4. The o/o shall maintain on-site, as a minimum, an inventory of replacement bags that assures compliance with applicable Rules of District Regulation IV.
5. The o/o shall install and maintain a device which measures the pressure differential across the bags if one is not provided with the unit.
6. This baghouse shall operate concurrently with W-3 & 4 Silos, District permit T000422, with the baghouse operating prior to transferring product and only shut down subsequent to the complete transfer of product.
