Description:

BAGHOUSE consisting of: BAGHOUSE which is described as a Torit, Model 84 which has 150 ft2 of polyester filter area. This unit uses a 3 hp electric driven fan rated at 1231 ACFM @ 5 in w.c.

CONDITIONS:

1. When solid materials are being added to the slurry blending tank this baghouse shall be operating concurrently.
2. The owner/operator (o/o) shall install, operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce minimum emissions of air contaminants
3. The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
4. The o/o shall install and maintain a device which measures the pressure differential across the bags if one has not been provided with this unit.
5. The o/o shall institute a program of maintenance which embraces at least weekly visible emission determinations, monthly visual inspections of all associated equipment (inclusive of the bags and their suspensions system) and regular (to be determined with experience with this unit) measurements of the pressure differential across the bags.
