Description:

BAGHOUSE CEMSTAR (DC-11), KILNS 1-5 consisting of: Baghouse: MAC, which is RCC designation DC-11. This unit has model 54AV16-3 and serial number 88-AVS-F07-011. The unit has 16 bags with 119 square feet of filter area and an air to cloth ratio of 5:1. 860 CFM at 6 inches of static pressure are produced by a 2 hp motor driving the fan (model 12SB-ARR4, serial 77-FANS-07-015).

CONDITIONS:

1. The owner/operator, (o/o), shall install, operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier, and sound engineering principles which produce minimum emissions of air contaminants.
2. The o/o shall have a maintenance plan for this baghouse. This plan, at a minimum, shall require a log that will include visual emission readings on a regular basis, recording of differential pressures across the baghouse and inspection/repairs frequency.
3. The o/o shall log all the items in 2 above in addition to the bag replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
4. The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
5. This baghouse shall operate concurrently with CemStar Feed System-Kilns 1 thru 5 and the associated 5 t/h weigh feeder to kiln 2 under valid District permit number B005145.
