Description:

BAGHOUSE DC30201 (DRY ROOM SACKER) consisting of: a DCE Model UMA1026 Serial Number 80-1220 baghouse equipped with 18 19.5" by 20" by 24" bags totaling 97.5 square feet of filter area and a 7.5 hp fan generating 1000 scfm (for an air to cloth ratio of 10.3:1). This unit serves the Dry Room packing equipment, and returns material to the drum dry silo through airlock AL34302.

CONDITIONS:

1. This equipment shall be operated concurrently with the bulk bagging and sacking equipment covered in District permit B000856.
2. The owner/operator (o/o) shall maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:
 - a. Monthly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
 - b. Quarterly bag and bag suspension system inspection date and results;
 - c. Date of bag replacements; and,
 - d. Date and nature of any system repairs.
4. This baghouse shall discharge no more than 0.09 pounds per hour of PM10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description. This equipment does not require a regularly scheduled emission compliance test.
