**Description:**

DUST COLLECTOR consisting of: a Torit Dust Collector described as model DF T2-8. This unit draws approximately 4,500 ACFM by means of a 7.5 hp electric motor driven fan. The collection medium consists of 8 web filters designed to operate at 10 inches of w.g. pressure.

**CONDITIONS:**

1. The owner/operator, (o/o), shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.
2. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request.
3. This baghouse shall operate concurrently whenever any of the Ribbon Blenders, or the Mixing, Blending and Storage equipment under valid District permits B005125, B005127, B005129, B008685, T005131 and B005076 is in operation.
4. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specification which ensures compliance with District Rules. This program shall include, but not be limited to, regular opacity determinations, pressure differential measurements, and maintenance inspections. The log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request.
5. This baghouse does not require regular emissions testing, but the District may require testing at its discretion.
