## **Description:**

BAGHOUSE consisting of:a CMI manufactured, model Roto Air RA-418P Baghouse. This baghouse is rated at 85,000 ACFM and powered by a 300 hp electric motor. The bags are Nomex, each 10.2 in in diameter and 6.75 ft long. The total filter area of the 1008 bags is 18,144 sq ft giving an A:C ratio of 4.68:1. This unit is reverse air cleaned.

#### **CONDITIONS:**

- 1. The owner/operator, (o/o), shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.
- 2. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request.
- 3. This baghouse shall operate concurrently with the Portable Asphalt Plant under valid District permit B008296.
- 4. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specification which ensures compliance with District Rules. This program shall include, but not be limited to, regular opacity readings, pressure differential measurements, and maintenance inspections. Logging of data shall be required with the log kept on site for a minimum of two (2) years. This log shall be provided to District personnel on request.
- 5. This baghouse does not require regular emissions testing, but the District may require testing at its discretion.
