DUST COLLECTOR #13 (SECONDARY HAMMERMIL #2 TRANSFER SYSTEM - 412) consisting of:A Flex-Kleen Model 25-PCBL-72, Filter Receiver, with 72 spun bond polyester laminate 24.6 square foot pleated cartridge filters totaling 1771 square feet of filter area, operating at 3630 cfm of flow (for an air to cloth ratio of 2.0:1). This system includes a two hp rotary discharge valve. Normal differential pressure across the integral baghouse cartridges is 2 to 5.5 inches water column as measured by integral manometer. Equipment Elevation is 236.5 feet; Note: plant floor level = 100' Vents to Atmosphere through the Roof of the Batching Tower, serves fine meal bins, at an elevation of 3053 feet above sea level.
