Description:

MIST COLLECTOR #16 (PROCESS LINE #1 COATER) consisting of: A Torit Model DMC-DQ1 mist collector, with 220 square feet of filter area, equipped with a 7.5 hp fan generating 2000 cfm of flow (for an air to cloth ratio of 9.1:1). This system includes a two hp rotary discharge valve.

CONDITIONS:

1. The owner/operator (o/o) shall maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.

2. This mist collector shall operate concurrently with the coater portion of Process Line #1 (B008780).

3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:

- Weekly mist collector stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- Quarterly filter and filter suspension system inspection date and results;
- Date of filter replacements; and,
- Date and nature of any system repairs.

4. This equipment shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty percent opacity.

5. This mist collector shall discharge no more than 0.17 pounds per hour of PM10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission
