Description:

BIN VENT SYSTEM #26 (BIN 708) consisting of: Bin vent filter equipped with a 0.75 hp fan generating 100 cfm of flow. This unit serves the Small Bag Packaging Line 8, Bin 708. This Bin Vent Filter vents internally within the Finish Product Tower building.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. This air pollution control device shall operate concurrently with the Small Bag Packaging Line 8, Bin 708.

3. The owner operator shall maintain on-site a minimum inventory of replacement filters for this dust collector that assures compliance with these conditions and District Rules and Regulations.

4. The owner operator shall conduct a minimum program of inspection and maintenance on this equipment, and maintain current and on-site for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:

- a. Quarterly filter support system inspection date and results;
- b. Date of filter replacements; and,
- c. Date and nature of any system repairs.

5. This air pollution control device shall not discharge an exhaust stream that exhibits greater than twenty (20) percent opacity.

[District Rule 401]

6. This air pollution control device shall discharge no more than 0.008 pounds per hour of PM₁₀ at a maximum concentration of 0.009 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.

7. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
