## **Description:**

ODOR ABATEMENT SYSTEM #5 (COMMON UNIT CHIMNEY) consisting of:a 8' 2" D by 108' H chimney, venting the exhaust of the three process line stacks, the two finished product tower vents and the heat exchanger room after a common plenum.

#### CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 2. This equipment shall have an exhaust to atmosphere not lower than 199 feet above ground level. [District Rule 1303]
- 3. Upon completion of construction of this equipment, not later than March 30, 2007, all process line ducted exhaust, the finished tower vents and the heat exchanger room shall only be directed to atmosphere through this equipment.

4.The finished tower vents shall be equipped with appurtenances sufficient to allow the installation of variable fan drives to modulate flow rates to maintain a minimum common unit chimney exit velocity if required in writing by the District.

5.Not less frequently than once once every twelve (12) months, beginning in 2007, the owner operator shall perform neighborhood odor monitoring (including the residential districts immediately to the east of the facility) as specified by the District, in accordance with the Compliance Test Procedural Manual. The first such neighborhood monitoring shall be performed within 30 days of the completion of this equipment. Additional monitoring (including at a higher frequency), may be required at the District's discretion.

The owner operator must submit a compliance certification test protocol at least thirty (30) days prior to the compliance certification test date. The owner operator must conduct all required compliance/certification tests in accordance with a District-approved test protocol. The owner operator must notify the District a minimum of ten (10) days prior to the compliance certification test date so that an observer may be present. The final compliance certification test results must be submitted to the District within forty-five (45) days of completion of the test. All compliance certification test notifications, protocols, and results may be submitted electronically to reporting@mdaqmd.ca.gov.

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
