#### **Description:**

BIN VENT SYSTEM #32 (BIN 2601) consisting of: A CPE Filters Model 36-BV-II-G bin vent located on Building Level 174, with 16 ounce polyester felt bags, equipped with a 0.75 hp fan generating 100 cfm of flow. This unit serves the Process Line 3 Dry Product Holding Bin, Bin 2601.

#### **CONDITIONS:**

1. The owner/operator (o/o) shall maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.

2. This unit shall operate concurrently with the dry product holding bin portion of Process Line 3 (B009720).

3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:

- Quarterly exhaust stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- Quarterly bag and bag suspension system inspection date and results;
- Date of bag replacements; and,
- Date and nature of any system repairs.

4. This unit shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty percent opacity.

5. This unit shall discharge no more than 0.02 pounds per hour of PM10 at a maximum concentration of 0.02 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test.
