### **Description:**

ODOR ABATEMENT SYSTEM #6 (COMMON UNIT DUCT) consisting of:a 7' D by 20' H duct, venting three process room vents through common ducting; the three vents are served by two 40 hp and one 50 hp exhaust fans. This duct stack will be located on the Process Building roof, and has a nominal exhaust rate of 109,500 cubic feet per minute.

Quarterly stack observation date and result, using EPA Method 22 (and EPA method 9 if Method 22 detects visible emissions. In lieu of Method 9, owner operator may cease operations until deficiencies contributing to opacity are corrected.), and b. Date and nature of any system repairs. [District Rules 1303]
