**Description:**

COMMON UNIT CHIMNEY HEATER #1 consisting of: An auxiliary natural gas-fired heater located in the duct from the Finished Product Tower Vent #1 (West) into the Common Unit Chimney, equipped with a Eclipse Winnox WX0600 low NOx burner rated at 6 MMBtu/hr with a 15 hp combustion air blower generating 121,000 scfh. This unit operates seasonally to maintain a minimum common unit chimney stack exhaust temperature for nuisance odor dispersion, and operates in conjunction with heater #2 (C009832).

**CONDITIONS:**

1. The owner/operator (o/o) shall install, operate and maintain this equipment in strict accord with the recommendations of the manufacturer/supplier and sound engineering principles.
2. This equipment shall be installed and operating not later than March 31, 2007.
3. The o/o shall constantly monitor the temperature of the gas within the Common Unit Chimney (CUC) at its midpoint, and the CUC midpoint exhaust gas temperature shall be used to automatically regulate the operation of this equipment. Compliance with this condition shall be demonstrated with an in-situ stack thermocouple and a heater automatic controller.
4. This equipment (and C009832) shall be used to maintain a minimum CUC midpoint gas temperature of 155 degrees Fahrenheit. Compliance with this condition shall be demonstrated with controller temperature set points.
