BAGHOUSE DC-1 consisting of:Donaldson DCE, DMLV, pulse jet type baghouse with 20 cloth bags, cloth area is 215 ft2 and air flow is 1500 cfm. Fan motor is 3 hp. This unit serves ElJay screen Equip. ID #5 associated with Aggregate Crushing & Screening Plant (B011501).

CONDITIONS:

- 1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. The owner/operator, o/o, shall operate and maintain this baghouse in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles.
- 3. This baghouse shall operate concurrently with the equipment described as the Portable Crushing and Screening Plant under valid District permit B011501.
- 4.The owner/operator, o/o, shall conduct the following minimum program of inspection/maintenance:
- a. Monthly visible emissions determinations; results logged;
- b. Weekly readings and recording of the pressure differential across the bags;
- c. Quarterly inspections of the bags and their suspension systems; inspections, replacements and repairs logged.

- 5.Within 180 days of start-up to demonstrate initial compliance with 40 CFR 60 Subpart OOO \S60.672(a) the owner/operator shall conduct the following tests pursuant to 40 CFR 60 Subpart OOO \S60.675:
- a.) Opacity: visual emissions evaluation using USEPA Method 9 (40 CFR part 60, Appendix A-4).
- b.) PM Concentration: USEPA Method 5

The tests must be conducted while the affected source is in operation.

6. Visible emissions from this baghouse shall not exceed seven (7) percent (40 CFR 60 Subpart OOO, Table 2).

7.The o/o shall maintain, on-site, an inventory of replacement bags sufficient to ensure compliance with applicable rules of District Regulation IV.
