1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
2. The owner/operator, o/o, shall operate and maintain this dust collector in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles.
3. This dust collector shall operate concurrently with the equipment described as the Oxalic Acid System under valid District permit B011859 or B011860.
4. The owner/operator, o/o, shall conduct the following minimum program of inspection/maintenance:
 - a. Monthly visible emissions determinations; results logged;
 - b. This system is equipped with an alarm which indicates when the pressure differential across the vent cartridges is out of range. Record incidents when the pressure differential alarm is triggered and the corrective actions taken;

c. Quarterly inspections of the vent cartridges; inspections, replacements, and repairs logged.

Items a, b, and c shall be logged. The log shall be maintained current, on-site for a minimum of 5 years and provided to District personnel on request.

5. The dust collector shall discharge no more than 0.01 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District.

6. The dust collector shall have no visible emissions.
