AIR POLLUTION CONTROL SYSTEM (LINE 2 POST COAT VERTICAL COOLER) consisting of:a high efficiency cylcone with inline filter receiving air flow from the Line 2 Post Coat Vertical Cooler (B008781), with a 75 hp induced draft fan rated at a maximum of 16,500 cfm (nominal 15,000 cfm), vented to an IONO2X odor control device (C013997) common with Line 1 Post Coat Vertical Cooler air pollution control system (C013995). This IONO2X unit exhausts to the Common Unit Chimney, CUC (C009709).

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2. This equipment shall operate concurrently with the post coat vertical cooler portion of Process Line #2 (B008781), and shall discharge into the IONO2X system under C013997. [District Rules 204 & 1303]
- 3. The owner operator shall maintain an operations, inspection, and maintenance log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. [District Rules 1303]

4. This air pollution control device shall not discharge into the atmosphere an exhaust stream that exhibits greater than twenty (20) percent opacity.

[District Rule 401]

5. This air pollution control device shall discharge no more than 2.83 pounds per hour of PM10 at a maximum concentration of 0.02 grains/dscf at the operating conditions given in the above description (BACT). This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District. [District Rules 404 and 1303]

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
