#### **Description:**

ODOR ELIMINATION SYSTEM (IONO2X) FOR POST COAT COOLERS 1 & 2 consisting of:a non-thermal plasma IONO2X odor reduction system processing a maximum of 33,000 cfm (30,000 cfm nominal) operating at 55 to 90 degrees Celsius and relative humidity up to 75%. This system processes exhaust flow from the Post Coat Cooler 1 and 2 high efficiency cyclones (C013995 and C013996), and discharges to atmosphere through the Common Unit Chimney (C009709).

#### CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2.This Odor Elimination System shall operate concurrently with C013995 and C013996. [District Rule 1302]
- 3. The owner operator shall maintain an operations, inspection, and maintenance log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. [District Rule 1302]
- 4.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District,
