CONDITIONS:

- 1. This dust collector must be installed, operated, and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2.This dust collector must be operated whenever the grout plant silos permitted under District permit T014121 are in operation. [District Rules 204 and 1303]
- 3. The owner/operator must conduct a minimum program of inspection and maintenance on this equipment. The owner/operator must maintain, current and on-site, for two (2) years a log of the following information, which shall be provided to District personnel upon request:
- a. Visible Emission Determination (VED) using the following procedures when the silos are being filled:
- (1) Ensure that the observer's back is to the sun or artificial light.
- (2) The observation spot provides a clear view of the emission point(s).
- (3) Observe the emission point(s) for a period of one minute.
- (4) Designate the emission point(s) as "dusting" or "not dusting". If "dusting" is occurring, owner/operator must conduct a Visible Emission Evaluation using USEPA Method 22, and USEPA Method 9, on each dusting emission point if necessary, or shut down the equipment immediately and effect the required equipment repairs.
- (5) Log the results of these observations; include the date and times that the observations were conducted; date and nature of any system repairs.

- c. Annual cartridge/filter and support system inspection date and results;
- d. Date of cartridge/filter replacements; and,
- e. Date and nature of any system repairs.

- 4. This dust collector and associated equipment must be operated such that no visible emissions from the equipment result in an opacity greater than 20 percent on the Ringelmann Chart for a period or periods aggregating more than three (3) minutes in any one hour. [District Rule 401(a)]
- 5. The owner/operator must maintain, on-site, a minimum inventory of replacement cartridges/filters to assure compliance with these conditions.

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
