### **Description:**

ODOR CONTROL AIR FILTRATION SYSTEM, CANNABIS CULTIVATION consisting of:A recirculation odor control filtration system consisting of 24 Can Filters Model Can-Lite 14 inch Filter Units, each having dimensions of 18 inches diameter x 49.21 inches long, containing 63.05 pounds of activated carbon with a sorbent depth of 2 inches, for a total of 1513.2 pounds of activated carbon. Each filter unit recirculates filtered air inside the building using a fan rated at TBD hp producing 3000 CFM air flow through a 14 inch diameter stack. In addition, a separate odor control filtration exhaust system, consisting of eight (8) Can-Filters Model Can-Lite 8 inch Filter Units, each having dimensions of 8 inches diameter x 40 inches long, containing 31.59 pounds of activated carbon with a sorbent depth of 2 inches, for a total of 252.7 pounds of activated carbon. Each filter unit exhausts air outside of the building using a fan rated at TBD hp, producing 1000 CFM air flow through an 8 inch diameter exhaust stack. The facility is located at an altitude of 2976 feet above MSL.

### **CONDITIONS:**

1. These air pollution control devices must be installed, operated, and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles to produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment must also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]

2.The Air Filtration Systems employed at this facility must have the manufacturer's recommended canisters properly installed whenever the system is in operation.

3.Odors from this equipment must be non-detectable and the activated carbon canisters must be changed any time breakthrough has

occurred. The owner/operator must conduct quarterly odor detection checks at the exhaust of the above described equipment to ensure that breakthrough has not occurred. If odors are detected, the filters must be changed immediately. If the exhaust of this equipment is not accessible, then the filters must be replaced at least once every three months.

[District Rules 204 and 402]

4. The owner/operator must take all steps necessary to preclude odor migration from this facility, including but not limited to, carbon filter change outs when breakthrough has occurred, keeping doors and windows closed to the maximum extent possible, isolating odor-emitting activities from other areas of the buildings through closing doors and windows, and operating all air filters continuously during cultivation activities.

- 5.An operations log of this equipment must be kept for a period of two (2) years, and must be made available upon request of District personnel. This log shall contain, as a minimum, the following information:
- a. The date and time of each activated carbon filter replacement;
- b. Results of quarterly odor monitoring checks (date and result); and,
- c. A copy of the manufacturer's specification for control efficiency for the activated carbon filters. [District Rules 204 and 1303]

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
