Description:

ODOR CONTROL AND SUPPRESSANT SYSTEM, CANNABIS consisting of: Composed of an odor mitigation system comprised of Cannabusters and Fogcos misting systems which injects a neutralizing formula (Cannabusters concentrate) into the mist. Facility elevation is 2422 feet above sea level. Please note: This odor mitigation system is manifolded and shared with Grow Organic 10.

CONDITIONS:

1. These air pollution control devices shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
2. Odors from this equipment shall be non-detectable. The owner/operator shall conduct quarterly odor detection checks at the perimeter of the building to ensure that the odor misting system is working properly. If odors are detected, the odor misting system and solution must be properly adjusted, until the odors are no longer detectable. [District Rules 204 and 402]
3. The owner/operator must take all steps necessary to preclude odor migration from this facility, including but not limited to, keeping doors and windows closed to the maximum extent possible, isolating odor-emitting activities from other areas of the buildings through closing doors and windows, and operating all odor control equipment continuously during cultivation activities.

4. Total quantity of Cannabusters concentrate used within this system is limited to 55 gallons/year.

5. A log pertaining to the operation of this equipment shall be kept for a period of two (2) years, and must be made available upon request of District personnel. This log shall contain, as a minimum, the following information:

a. The date and time of each odor additive (Cannabusters) refill;

b. Results of quarterly odor monitoring checks.

6. A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
