EMERGENCY DIESEL ELECTRICITY GENERATOR (BLDG 1024) consisting of:a Detroit Diesel engine driving a generator. The engine is rated at approximately 670 bhp and drives a Beloit Power Systems, Inc. Generator, which is rated at 500 kW(e), 625 kVA.

### **CONDITIONS:**

- 1. Operation of this equipment shall be conducted in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
- 3. This unit shall be limited to use for emergency power, defined as when commercially available power has been interrupted, and as part of a testing program which does not exceed 60 minutes of operation per week.
- 4.The owner/operator (o/o) shall use only diesel fuel or biodiesel B20 fuel whose sulfur concentration is less than or equal to 0.05% on a weight per weight basis or JP-8 fuel.
- 5. The o/o shall maintain a log for this unit, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of two (2) years and shall be provided to District personnel on request:
- a. Date of each test;
- b. Duration of each test, in minutes:
- c. Annual operation in terms of total calendar year fuel use (in gallons) or hours;
