OneCaterpillar, Diesel fired internal combustion engine Model No.3508 and Serial No.1ZF00656, Direct Injected, Turbo Charged, producing1456 bhp with8 cylinders at1800 rpm while consuming a maximum of30.0gal/hr. This equipment powers aCenturyGenerator Model No.SR-4 and Serial No.6NA02680, rated at1000 kW(e).

Brad Poiriez Air Pollution Control Officer 2.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this equipment to indicate elapsed engine operating time. [17 CCR 93115.10(d)]

3. This engine shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15 ppm) on a weight per weight basis per CARB Diesel or equivalent requirements. [17 CCR 93115.5(a)]

4. This equipment shall be limited to use for emergency power, defined as in response to a fire or when commercially available power (or the normal power source) has been interrupted. In addition, this unit shall be operated no more than 20 hours per year for testing and maintenance.

[17 CCR 93115.6(b)(3)]

5. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State, and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:

a. Date of each use and duration of each use (in hours);

b. Reason for use (testing & maintenance, emergency, required emission testing);

c. Maintenance records including corrective actions undertaken to restore engine to its normal operating mode following a malfunction; [40 CFR 63.6655(a)(5)]

d. Calendar year operation in terms of total hours; and

e. Fuel purchase records.

6. This equipment may operate in response to notification of impending rotating outage if the area utility has ordered rotating outages in the area where the engine is located or expects to order such outages at a particular time, the engine is located in the area subject to the rotating outage, the engine is operated no more than 30 minutes prior to the forecasted outage, and the engine is shut down immediately after the utility advises that the outage is no longer imminent or in effect. [17 CCR 93115.6(b)(1)]

7. This equipment shall not be used to provide power during a voluntary agreed to power outage and/or power reduction initiated under an Interruptible Service Contract (ISC); Demand Response Program (DRP); Load Reduction Program (LRP) and/or similar arrangement(s) with the electrical power supplier. [17 CCR 93115.6(c)(2)(C)]

8. The facility must submit accurate emissions inventory data to the District, in a format approved by the District, upon District request.

9. This engine meets the definition of an existing institutional emergency stationary RICE pursuant to 40 CFR 63, Subpart ZZZZ. Furthermore, this existing institutional emergency stationary RICE is exempt from 40 CFR 63, Subpart ZZZZ per 63.6585(f)(3).

Per this exemption, this existing institutional emergency stationary RICE located at an area source of HAP emissions shall not operate, nor contractually obligate to be available, for more than 15 hours per calendar year for the purposes specified below: a. Operation for emergency demand response for periods in which the Reliability Coordinator under the North American Electric Reliability Corporation (NERC) Reliability Standard EOP-002-3, Capacity and Energy Emergencies, or other authorized entity as determined by the Reliability Coordinator, has declared an Energy Emergency Alert Level 2 as defined in the NERC Reliability Standard EOP-002-3.

b. Operation for periods where there is a deviation of voltage or frequency of 5 percent or greater below standard voltage or frequency.

Additionally, per this exemption, this existing institutional emergency stationary RICE located at an area source of HAP emissions shall not operate for non-emergency use as part of a financial arrangement with another entity.

Upon loss of this definition and/or exemption, immediate compliance with 40 CFR 63, Subpart ZZZZ - National Emission Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines (NESHAP) is required.
