## **CONDITIONS:**

- 1. This engine shall only be operated to fight fires and for testing, no more than one hour in any one day and in any one week.
- 2. The fuel used to operate this equipment shall not contain more than 0.05% sulfur on a weight to weight basis.
- 3. The owner/operator (o/o) shall require analytical results relating to the sulfur content of the fuel delivered by their supplier. The o/o shall not accept delivery whenever the sulfur concentration exceeds 0.05% by weight.
- 4.The o/o shall log the starting and stopping times, the "hour meter" reading, and the date each time the engine is operated and copies of fuel delivery including sulfur concentration. This log shall be maintained current, on-site for a minimum of two years and provided to District personnel upon request.
- 5. The o/o shall comply with all applicable MDAQMD Rules and Regulations.
