DIESEL IC ENGINE, EMERGENCY GENERATOR consisting of: Electro Motion 175 kW(e) electrical generator, Model 500FDC, S.N. CC92967, (mobil equipment), powered by

One Allis Chalmers, Diesel fired internal combustion engine Model No. 613LT and Serial No. 14-04061, producing 235 bhp with 6 cylinders at 1800 rpm while consuming a maximum of 18.0 gal/hr. This equipment powers a Generator Model No. and Serial No., rated at.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.
2. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time.
3. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15ppm) on a weight per weight basis per CARB Diesel or equivalent requirements.
4. This unit shall be limited to use for emergency power, defined as in response to a fire or when commercially available power has been interrupted. In addition, this unit shall be operated no more than 20 hours per year for testing and maintenance, excluding compliance source testing. Time required for source testing will not be counted toward the 20 hour per year limit.
5. The o/o shall maintain a operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and
