OneCUMMINS, Diesel fired internal combustion engine Model No.N-855PG250 and Serial No.32527, producing231 bhp with6 cylinders at rpm while consuming a maximum of8.0gm/bhp-hr. This equipment powers a Model No. and Serial No., rated at.

CONDITIONS:

- 1.The owner/operator (o/o) shall log the starting and stopping times of the operational periods of this generator, to the nearest minute, and the date.
- 2.The o/o shall use only diesel fuel whose sulfur concentration is less than or equal to 0.05% by weight or JP-8 fuel.
- 3. The o/o shall log all purchases of diesel fuel including the volume (or weight), date received and the sulfur content. The o/o may use the supplier's furnished certification of sulfur content if the certifications are maintained on file as a part of the log.
- 4.The logs shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request.
- 5.The o/o is limited to operating this generator to 1.0 hr/wk for test purposes, and for emergency purposes, which is defined as when commercially available power has been interrupted.
