OneCummins, Diesel fired internal combustion engine Model No.4BT3.9-G2 and Serial No.44681849, Turbo Charged, producing 86 bhp with 4 cylinders at 1800 rpm while consuming a maximum of 4.0gal/hr. This equipment powers a DMT Corporation Generator Model No.50C2 and Serial No.91423-1, rated at 45 kW.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles, which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302(B)(1)(a): 40 CFR 63.6640(a) and Table 2c]

2.Engine may operate in response to notification of impending rotating outage if the area utility has ordered rotating outages in the area where the engine is located or expects to order such outages at a particular time, the engine is located in the area subject to the rotating outage, the engine is operated no more than 30 minutes prior to the forecasted outage, and the engine is shut down immediately after the utility advises that the outage is no longer imminent or in effect.

3.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [Title 17 CCR 93115.10(d); 40 CFR 63.6625(f)]

- 4.This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15ppm) on a weight per weight basis per CARB Diesel or equivalent requirements. District, State enforceable only.

- 5.This unit shall be limited to use for emergency power, defined as in response to a fire or when commercially available power has been interrupted. In addition, this unit shall be operated no more than 20 hours per year for testing and maintenance, excluding compliance source testing. Time required for source testing will not be counted toward the 20 hour per year limit.

 [District Rule 1302(B)(1)(a); 17 CCR 93115.6(b)]
- 6.This unit shall be limited to emergency use only, as defined in 40 CFR 63.6640(f). In addition, this unit shall be operated no more than 100 hours per rolling consecutive twelve month period for testing and maintenance, including compliance source testing. [District Rule 1302(B)(1)(a); 40 CFR 63.6640(f)]
- 7.The o/o shall maintain a operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date of each use and duration of each use (in hours per hour meter);
- b. Reason for use (testing & maintenance, emergency, required emission testing);
- c. Calendar year operation in terms of fuel consumption (in gallons) and total hours;
- d. Records of all required maintenance and inspection actions listed in condition #9; and
- e. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log). [District Rule 1302(B)(1)(a); 17 CCR 93115.10(f); 40 CFR Subsection 63.6655; 40 CFR 70.6(a)(3)(ii)(b)]
- 8. The owner/operator shall minimize the engine's time spent at idle during startup and minimize the engine's startup time to a period needed for appropriate and safe loading of the engine, not to exceed 30 minutes.

- 9. This unit shall not be used to provide power during a voluntary agreed to power outage and/or power reduction initiated under an Interruptible Service Contract (ISC); Demand Response Program (DRP); Load Reduction Program (LRP) and/or similar arrangement(s) with the electrical power supplier.

- 10.Owner/operator must meet the following requirements;
- a. Change oil and filter every 500 hours of operation or annually, whichever comes first, or use an oil change analysis program to extend oil change frequencies per the requirements in 40 CFR 63.6625(i):
- b. Inspect air cleaner every 1,000 hours of operation or annually, whichever comers first, and replace as necessary: and
- c. Inspect all hoses and belts every 500 hours of operation or annually, whichever comes first, and replace as necessary; and [40 CFR 63.6630(a); Table 2c; 40 CFR 63.6640(b); 40 CFR 63.6650(d)]
- 11. This engine is subject to the requirements of the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines Title 17 CCR 93115 and 40 CFR 63 Subpart ZZZZ (RICE NESHAPs). [District Rule 1302(B)(1)(a)]
- 12.A facility-wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request. [Rule 107(b), HSC 39607 and 44341-44342, 40 CFR 51, Subpart A]
