- 2.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [17 CCR 93115]
- 3. This engine shall only be fired on diesel fuel that meets the following requirements, or an alternative fuel approved by the ATCM for Stationary CI Engines:
- a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,
- b. A cetane index or aromatic content, as follows: (i) A minimum cetane index of 40; or, (ii) A maximum aromatic content of 35 volume percent. [17 CCR 93115.5(a), 40 CFR 80.510(b), and 40 CFR 63.6604]

Note: Use of certified California Ultra-Low Sulfur Diesel (ULSD) fuel meets the requirements of subparagraph 3.b above. [District Rule 431; 17 CCR 93115]

- 4.This engine shall not be operated for non-emergency use (e.g. maintenance and testing) between the hours of 7:30 a.m. and 3:30 p.m. on days when Morongo Jr. High School and/or Twentynine Palms Elementary School are in session. [17 CCR 93115.6]
- 5.This unit shall be limited to use for emergency power, defined as in response to a fire or flood, or when commercially available power has been interrupted. In addition, this unit shall be operated no more than 30 hours per year for testing and maintenance. [17 CCR 93115; 40 CFR 60.4211(f)]
- 6. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date and time of day of each use and duration of each use (in hours);
- b. Reason for use (testing & maintenance, emergency, required emission testing, etc.);
- c. Monthly and calendar year operation in terms of fuel consumption (in gallons) and/or total hours [17 CCR 93115]; and,
- d. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log) [17 CCR 93115].
- 7.This unit shall not be used to provide power during a voluntary agreed to power outage and/or power reduction initiated under an Interruptible Service Contract (ISC); Demand Response Program (DRP); Load Reduction Program (LRP) and/or similar arrangement(s) with the electrical power supplier.

- 8. This unit shall be operated and maintained so as to meet the requirements of the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines (17 CCR 93115) and New Source Performance Standards (NSPS) for Stationary Compression Ignition Internal Combustion Engines (40 CFR Part 60, Subpart IIII.
- 9.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
