OneCummins, Inc., Diesel fired internal combustion engine Model No.QSB7-G9 and Serial No.74887439, Charge Air Cooler, Turbo Charged, producing 314 bhp with 6 cylinders at 2250 rpm while consuming a maximum of 11.3 gal/hr. This equipment powers a Cummins Generator Model No.C150D2RE and Serial No.TBD, rated at 150 kW.
