PAINT AIR BRUSH (Bldg 560 & 561) consisting of: Strip 8; Binks Model Wren No. 59, HVLP Gun.

**CONDITIONS:**

1. This gun may be operated outside of the main area of operation and/or a spray booth.
  
2. All coatings, diluents, thinners and solvents shall comply with District Rules 1113, Architectural Coatings; 1114, Wood Products Coating Operations; 1115, Metal Products Coatings; 1116, Automotive Refinishing Operations; or 442, Usage of Solvents..
  
3. A log shall be maintained of the VOC emissions from this facility which contains as a minimum, the following:
  - a. The identification number of the equipment applying the coating;
  - b. The type of coating and its VOC content limit under Rules 1113, 1114, 1115, and 1116;
  - c. Quantity of coating applied and its VOC content; and
  - d. Total VOCs generated by b. and c. above covered by Rules 1113, 1114, 1115, 1116, and 442.
  - e. Type of material being coated.
  
4. The log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request. (Note: the daily log information provides the basis for the Toxic Emission Inventory consistent with AB 2588.)
  
5. The owner/operator (o/o) shall operate equipment described in this permit in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emission of air contaminants. Spray equipment shall be given unique identification marks attached thereto prior to use under this permit.
