### **Description:**

PAINT GUN (BLDG 621) consisting of:a Brinks MACH I, HVLP whose serial number is 621-001. This unit is used for painting outside of building 621 and will only use water based coatings whose VOC content is 0.65 lb/gallon.

### **CONDITIONS:**

1.All coatings, diluents, thinners and solvents shall comply with District Rules 1114, 1115, 1116 and 442 in their entirety. These rules pertain to Wood Products Coating Operations; Metal Parts & Products Coatings Operations; Automotive Refinishing Operations and Photochemically Reactive Solvents respectively.

- 2.A daily log shall be maintained which contains at least the following items:
- a. Equipment used to apply coating;
- b. Type of coating used and its VOC limit under each applicable rule;
- c. Quantity of coating used and its VOC content;
- d. Total VOC emissions; and
- e. Type of material being coated.

This log shall be kept current, on-site for a minimum of five (5) years and provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588.)

- 3.All equipment used at this facility shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier.
- 4. The total mass of VOCs emitted from this operation without regard to where or how it is generated shall not exceed 25.0 tons per year.
