Unit is powered by an exempt 13 bhp Honda engine and is capable of holding up to 240 lbs of beads and up to 30 gallons of paint. Maximum paint application rate is 2.5 gpm at 3300 psi.

CONDITIONS:

- 1. This pavement striping system shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2.All coatings and solvents used by this system shall comply with District Rule 1113 Architectural Coating Operations. No traffic marking coatings shall exceed a VOC content of 100 grams per liter, as applied.

- 4.No photochemically reactive compounds shall be used by this system, including the coating as purchased and any solvents which may be used as a diluent, thinner, reducer or cleaner.
